- ✗ Claims intentionally caused
- ✗ Illness / Accident: previous condition, alcohol claim, dental care and treatment, drug use, caused by an intentional act of the insured, due to civil wars, civil riots, costs of prostheses, breaking of spectacle frame and glasses, contacts

 **Limit of coverage**
